Description:

CYCLONIC INCINERATOR, COFFEE ROASTER consisting of:A Loring S-15 Falcon Smart Roaster that includes an integral cyclonic incinerator chamber for smoke and odor control. Device has a maximum BTU Rating of 150,000 Btu/hr and is fueled on Natural Gas. Stack is 0.5 inches in diameter, and 16 feet tall; Facility Elevation is 2737 feet above sea level. Stack temperature is 1400 degrees F, and stack flow is 22 cubic-feet/minute.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

- 3.An operations log shall be maintained with this equipment for at least two (2) years and made available to Federal, State, and/or District personnel upon request. This log shall contain, at a minimum:
- a) The date and pounds of coffee beans roasted per day:
- b) The total quantity of coffee beans roasted (pounds) for each consecutive twelve-month period; and
- c) The total quantity of Natural Gas Usage (MMscf) for each consecutive twelve-month period. [District Rule 1303(A)(1) and 1320(B)(2)(i)]

- 4. This facility shall not roast coffee in excess of 4752 pounds per day, and no more than 867.24 tons per year. [District Rule 1302]
- 5. This permit is contingent upon compliance with District Rule 402 Nuisance. Upon receipt of violation of Rule 402, the District may require the owner/operator to submit, within 60 days of notification, a permit application for the installment of additional emission control and/or curtailment of operations until either the operation can be modified or the meteorological conditions change such that the operation of this equipment no longer cause nuisance.

- 6.A person shall not discharge into the atmosphere from any single source of emission whatsoever any air contaminant for a period or periods aggregating more than three minutes in any one hour which is:
- a. As dark or darker in shade as that designated No. 1 on the Ringelmann Chart (20%), as published by the United States Bureau of Mines.
