Total Filter Area = 130 square meters; Exhaust fan powered by 11 Kw motor (14.7 hp) with a flow rate of 11000 N cubic meters per hour (6474 cfm); Air to Cloth ratio is 4. This Filter Receiver is located on the Batching and Hammermill Tower Roof, and vents to atmosphere at an elevation of 3060 feet above sea level.
