Description:

BIN VENT INTERMEDIATE STORAGE SYSTEM (BIN 5051) consisting of:A Horizon Model 58RF7 bin vent filter located on Bin 5051; equipped with 7 polyester bags, powered by a 3 hp fan generating 1530 cfm of flow. This unit serves the Intermediate Storage System operating with District Permit B014490. Bin Vent Filter vents internally within the Intermediate Storage Tower, and ultimately vents to atmosphere through the Common Unit Chimney (CUC).

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 1302]
- 2. This air pollution control device shall operate concurrently with the INTERMEDIATE STORAGE SYSTEM permitted as B014490. [District Rule 1302]
- 3. The owner operator shall maintain on-site a minimum inventory of replacement filters for this dust collector that assures compliance with these conditions and District Rules and Regulations.

- 4. The owner operator shall conduct a minimum program of inspection and maintenance on this equipment, and maintain current and onsite for five (5) years a log of the following information, which shall be provided to District, State or Federal personnel upon request:

c. Date and nature of any system repairs. [District Rules 1303]

5. This air pollution control device shall not discharge an exhaust stream that exhibits greater than twenty (20) percent opacity. [District Rule 401]

6. This air pollution control device shall discharge no more than 0.003 pounds per hour of PM10 calculated at 0.0002 grains/dscf at the operating conditions given in the above description. This equipment does not require a regularly scheduled emission compliance test. However, emission compliance testing may be required at the discretion of the District. [District Rules 404 and 1303]

7.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
