#### **Description:**

EMERGENCY DIESEL GENERATOR AT BLDG 1130, FACILITY MAINTENANCE YARD consisting of:

One Fremont Division, Diesel fired internal combustion engine Model No. 3306 and Serial No. 49500159, producing 235 bhp with cylinders at rpm while consuming a maximum of. This equipment powers a Generator Model No. MEP 007B and Serial No. FZ-1090, rated at 100.

#### **CONDITIONS:**

1. The owner/operator (o/o) shall log the starting and stopping times of the operational periods of this generator, to the nearest minute, and the date.
2. The o/o shall use only diesel fuel whose sulfur concentration is less than or equal to 0.05% by weight or JP-8 fuel.
3. The o/o shall log all purchases of diesel fuel including the volume (or weight), date received and the sulfur content. The o/o may use the supplier's furnished certification of sulfur content if the certifications are maintained on file as a part of the log.
4. The logs shall be maintained current, on-site for a minimum of 2 years and provided to District personnel on request.
5. The o/o is limited to operating this generator to 1.0 hr/wk for test purposes, and for emergency purposes, which is defined as when commercially available power has been interrupted.
