## **Description:**

EMERGENCY ELECTRICITY GENERATOR AT BLDG 2102 consisting of: a Hercules, model D4800T X242, serial number 4024603. This engine uses diesel fuel, is rated at 165 bhp and has 6 cylinders. The engine is direct injected, turbo-charged and normally runs at 1800 rpm.

#### **CONDITIONS:**

- 1. Operation of this equipment shall be conducted in accordance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
- 2. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants.
- 3. This unit shall be limited to use for emergency power, defined as when commercially available power has been interrupted, and as part of a testing program which does not exceed 8 hours of operation per month.
- 4.The owner/operator (o/o) shall use only diesel fuel whose sulfur concentration is less than or equal to 0.05% on a weight per weight basis in this unit.
