- 3. This unit shall be limited to use for emergency fire fighting. In addition, this unit may be operated as part of a testing program that does not exceed 50 hours of testing or maintenance per calendar year.
- 4. This unit shall only be fired on ultra-low sulfur diesel fuel, whose sulfur concentration is less than or equal to 15 ppm on a weight basis per CARB Diesel or equivalent requirements.
- 5. The o/o shall maintain a log for this unit, which, at a minimum, contains the information specified below. This log shall be maintained current and on-site for a minimum of five (5) years and shall be provided to District personnel on request:
- a. Date of each use or test:
- b. Duration of each use or test in hours:
- c. Reason for each use;
- d. Cumulative calendar year use, in hours; and,
- e. Fuel sulfur concentration (the o/o may use the supplier's certification of sulfur content if it is maintained as aprt of this log).
- 6.A non-resettable four digit timer shall be installed and maintained on this unit to indicate elapsed engine operating time.
- 7. This equipment shall comply with the applicable requirements of the Airborne Toxic Control Measure (ATCM) for Stationary Compression Ignition engines (Title 17 CCR 93115).
