- 2. This unit shall be limited to use for emergency power, defined as in response to a fire or flood, or when commercially available power has been interrupted. In addition, this unit shall be operated no more than 100 hours per year for testing and maintenance.
- 3. This unit shall not be used to provide power during a voluntary agreed to power outage and/or power reduction initiated under an Interruptible Service Contract (ISC); Demand Response Program (DRP); Load Reduction Program (LRP) and/or similar arrangement(s) with the electrical power supplier. [Subpart 60.424317(d)]
- 4.Owner/operator must keep, at a minimum, the following information in electronic or hardcopy format. This information must be kept onsite, or at a central location (agreed to by the District) for a minimum of two years and shall be provided to District. State, or Federal personel upon request.
- a. Annual hours of operation (from the non-resettable hour meter);
- b. Maintenance conducted on the equipment listed above; and
- c. Fuel purchase records.
- 5.A non-resettable hour meter with a minimum four digit display capability shall be installed and maintained on this engine to indicate elapsed engine operating time. [40 CFR 60.425]
- 6. This unit shall only be fired on propane gas.
- 7. The owner/operator shall provide a comprehensive emission inventory report, in a format approved by the District and according to District emission inventory guidance, upon District request.
