2. This equipment shall be operated by trained personnel; operating instructions shall be available at the incinerator at all times.

3. This unit shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier.

b. Weight of material disposed; recording daily, monthly and yearly totals; and,



5. This crematory shall only be used for disposal of animal remains.

6.Visible emissions from this equipment shall not exceed Ringelmann 1 (20%) opacity for a period or periods aggregating more than three minutes in any one hour, as required by District Rule 401, Visible Emissions.

7. This crematory incinerator may be operated concurrently with the incinerators operating under valid District Permits 1005217 or 1009631, co-located at this facility. Additionally, this unit may be operated a maximum of 11 hours/day, 7 days/week for a total not to exceed operation of 330 hrs/month. The total combined crematory incinerator hours shall not exceed 990 total combined hours of operation per month when all three incinerators (1005217, 1009631 & 1008727) operating hours are combined.
