- 4.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [17 CCR 93115.10(d)]
- 5.The Diesel Particulate Matter emission from this diesel engine must be equal to or less than 0.01 grams per brake horsepower-hour. [17 CCR 93115.7(b)]
- 6. The owner/operator shall maintain an operations log for this equipment current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:
- a. Monthly and calendar year operation in terms of total hours [17 CCR 93115.10(e)]; and,
- b. Fuel sulfur concentration (the owner/operator may use the supplier's certification of sulfur content if it is maintained as part of this log); and,
- c. Maintenance performed on this equipment, inclusive of the management practice requirements of condition 7 below [40 CFR 63.6655(a)(4)]; and,
- d. Records of the occurrence and duration of each malfunction of operation (i.e., process equipment) or the air pollution control and monitoring equipment [40 CFR 63.6655(a)(2)]; and,
