c. Quatity of coating applied and its VOC content; and

d. Total VOCs generated by b. and c. above covered by Rules 1113, 1114, 1115, 1116, and 442.

e. Type of material being coated.

4. The log shall be maintained current, on-site for a minimum of 2 years and provided to District personnel on request. (Note: the daily log information provides the basis for the Toxic Emission Inventory consistent with AB 2588.)
