CONDITIONS:

- 1.All coatings and solvents shall comply with District Rule 1113 Architectural Coating Operations.
- 2.No photochemically reactive portion of the coating is permitted. This includes the coating as purchased and any solvents which may be used as diluent, thinner, reducer or cleaner.
- 3. The o/o shall keep the log current, on-site for a minimum of two (2) years and provide it to District personnel on request.
- 4.The owner/operator (o/o) shall operate only one piece of equipment described in this permit at a time and then in strict accord with the recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emission of air contaminants.
- 5. The o/o shall maintain a daily log which includes all of the following:
- a. use of all VOC, inclusive of all mentioned in Condition 1. above;
- b. quantity and description of all VOC containing materials mentioned in Condition 1. above; and
- c. total hours operated.

6. The o/o shall be limited to operating to 2080 hours per calendar year.

7. This facility shall emit less than the following on a calendar year basis;

Oxides of Nitrogen (NOx) - 25 tons,

Volatile Organic Compound (VOC) - 25 tons,

Particulate Matter less than 10 microns (PM10) - 15 tons, and

Hazardous Air Pollutants (HAP) - 10 tons per year for any single HAP and 25 tons per year for any combination of HAPs. Compliance shall be demonstrated annually to the District through the submission of a District approved Comprehensive Emission Inventory Report (CEIR) or other District approved equivalent method. The report shall be submitted to the District no later than April 30 of each year.
