#### **Description:**

PROCESS TANK, C-LINE, MIXED ACIDS (HF AND HNO3), MILLING TITAINIUM consisting of: Tank No. C-2, which is a PVC lined stainless steel tank. This tank is 27 ft by 6.4 ft and 12 ft deep. This tank uses concentrated hydrofluoric acid (HF), and nitric acid (HNO3) at 110 degrees F. Operating capacity: 14, 250 gallons

### CONDITIONS:

- 1. This tank shall not be used unless it is vented to the properly functioning scrubber under valid District permit C001571. [District Rules 1303 and 1320]
- 2. The owner/operator shall maintain an operations log for this equipment current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:
- (a) Daily production of all pump-outs;
- (b) All additions to the tank;
- (c) Amount of metal removed; and,
- (d) All maintenance and repairs made on this equipment.

3. This tank/process shall be limited to use on titanium products, parts, and/or materials. [District Rules 1303 and 1320]

- 4.The Operating Procedure, which has been established, shall be provided to District personnel on request. [District Rule 204]
- 5.Emissions from this facility must not exceed the following limits. The owner/operator must demonstrate compliance with these facility-wide emissions limits by calculating and recording, in tons, on a calendar month basis; and, totaling each consecutive twelve-month period.
- (a) 15 tons of PM10
- (b) 25 tons of NOX
- (c) 25 tons of VOC

Emission calculations must be calculated using a District-approved method. The owner/operator shall maintain these calculations (monthly and consecutive twelve-month period totals), current and on-site (or at a central location) for a minimum of five (5) years, and must provide this data to District, State and/or Federal personnel, upon request.

6.The owner/operator must submit a facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
