TANK, WASTE OIL HOLDING consisting of:2,650 gallon cylindrical tank 8 ft high and 8 ft in diameter with a 24 inch top entry manway, a 16 in by 30 in hinged top manway and six 4 in flange connections (inlet, outlet, drain, overflow, vent and level switch)

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles in a manner consistent with good air pollution control practice for minimizing emissions. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

- 2. The owner/operator shall strictly adhere to all Federal, State, and/or District rules and regulations which pertain to the storing, handling, transferring, transporting, and disposing of waste oils. [District Rule 1302(C)(2)(a)]
- 3.Only crankcase and other waste oil shall be transferred and/or stored into/in this tank. [District Rule 1302(C)(2)(a)]
- 4.All of the components of this tank, including but not limited to tanks, flanges, seals, pipes, pumps, valves, meters, connectors, shall be maintained and operated so as to prevent fugitive vapor leaks, fugitive liquid leaks, and excess organic liquid drainage during transfer,
