CONDITIONS:

- 1.The owner/operator (o/o) shall install, operate and maintain all equipment described in this permit in strict accord with the recommendations of the manufacturer or supplier and/or sound engineering principles which produce the minimum emission of air contaminants.
- 2.The two 400 gallon tanks are limited to storing waste oil generated on-site by Wal-Mart during the normal course of conducting retail business.
- 3. The 250 gallon tank is limited to storing waste oil generated off-site by non-retail customers.
- 4.The only material that can be stored in these tanks shall be internal combustion engine crankcase drainage oil.
- 5.All flanges, seals, pumps and other appurtenant equipment shall be installed and maintained to prevent the loss of volatile fractions.
- 6. The owner/operator (o/o) shall log all shipments of oil to other parties and the hauler of the oil. Additionally, this log shall contain the mass (or volume) and the date of the oil shipment.
