Description:

DIP TANKS consisting of: Aqueous etchant and desmut solutions for chemical milling of aluminum: Two stainless steel heated dip tanks vented to atmosphere via hood vent fans. Tank #1 holds a solution consisting of approximately 14% Sodium Hydroxide, 4% Sodium Sulfide, and 2% Triethanolamine in water and Tank #2 holds a solution of 10% to 20% Nitric Acid in water.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [Rule 204]
2. These tanks shall only be used to etch and desmut Aluminum metal and shall not be heated above a maximum temperature of 210 degrees Fahrenheit. [District Rules 1302 and 1320]
3. These tanks shall be fully covered whenever it is not being actively used. [District Rules 204 and 1320]
4. All parts dipped in the etchant tank shall be thoroughly rinsed with water prior to being dipped into the desmut tank. [District Rules 204 and 1320]
