BULK CLASS B FACILITY consisting of:Next to Bldg 517, Two aboveground storage tanks, one (No. 11661 white) 20,000 gallon with JP-8 and one (No. 11660 blue) 20,000 gallon with AvG. Both tanks are 24'L and 12' diameter.

CONDITIONS:

1. The owner/operator (o/o) shall comply with all requirements of District Rules 462 and 463.

2. The o/o shall maintain records that include the following information:

- A. Inspections, repairs, and maintenance on equipment subject to these rules.
- B. Daily throughput.
- C. A monthly summary of the throughput for the calendar year to date.

These records shall be maintained at the facility for at least two years and shall be available to the District upon request.

3. The owner/operator (o/o) shall completely offset the maximum annual potential-to-emit for permitted and unpermitted equipment used in the support/operations of aircraft and/or an airfield, including aerospace ground equipment, added after April 1, 1999 at this facility that replace or perform essentially the same function as equipment for which emission reduction credits have been issued. Aerospace ground equipment include towing vehicles, lighting systems, lifts, generators, compressors, cooling systems, heating systems, miscellaneous hydraulic equipment, and similar equipment. The o/o shall maintain a current, on-site list of replacement equipment; said list shall include equipment description, serial or identifying number, date equipment was offset, and maximum annual potential-to-emit. The o/o shall prepare a comprehensive emissions inventory upon request by the District.
