Brad Poiriez Air Pollution Control Officer 2.All of the components of this tank, including but not limited to tanks, flanges, seals, pipes, pumps, valves, meters, connectors, shall be maintained and operated so as to prevent fugitive vapor leaks, fugitive liquid leaks, and excess organic liquid drainage during transfer, storage and handling operations. [District Rule 463(C)(3)]

3. The owner/operator shall log the amount of diesel fuel delivered to these tanks and the date of delivery. This log shall be maintained for two (2) years current and on-site, and shall be provided to District, State or Federal personnel upon request. [District Rule 1320]

4. The owner/operator shall maintain a log of all inspections, repairs, and maintenance on equipment. Such logs or records shall be maintained at the facility for at least two (2) years and shall be available to the District upon request. [District Rule 463]

5.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request. [District Rule 107(b); H&S Code 39607 & 44341-44342; and 40 CFR 51, Subpart A]
