This equipment shall not discharge an exhaust stream that exhibits opacity greater than twenty percent (Ringlemann 1) for more than three minutes in any one hour. - 3. The temperature of the asphalt in this equipment shall not reach a level that produces visible blue smoke.
- 3. This unit shall only be fired on ultra-low sulfur diesel fuel, whose sulfur concentration is less than or equal to 0.0015% (15 ppm) on a weight per weight basis per CARB Diesel or equivalent requirements.

- 4.An identification tag or nameplate shall be displayed on the equipment to show manufacturer model number and serial number. The tag(s) or plate(s) shall be issued by the manufacturer and shall be adhered to the equipment in a permanent and conspicuous position.
- 4.The owner/operator (o/o) shall maintain an operations log for this unit current and on-site for a minimum of two (2) years. This log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Date of each use and duration of each use (in hours);
- b. Calendar year operation in terms of fuel consumption (in gallons) and total hours; and,
- c. Fuel sulfur concentration (the o/o may use the supplier's certification of sulfur content if it is maintained as part of this log). [District Rules 204 and 1303]
- 5. Current contact person name, company, and phone number shall be displayed in a permanent and conspicuous position.
- 5. This equipment is portable and can be used by MWD at other various MWD sites throughout the District. This unit will be stored at the Iron Mountain Pumping Plant when not in use. [District Rules 204 and 1303]
- 6. This portable equipment shall not be operated closer than 1000 feet from the outer boundary of the nearest school (K-12).
- 6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.

- 7. Pursuant to Rule 401, Visible Emissions; A person shall not discharge into the atmosphere from any single source of emission whatsoever any air contaminant for a period or periods aggregating more than three minutes in any one hour which is:

 (a) As dark or darker in shade as that designated No. 1 on the Ringelmann Chart; I.E. 20% Opacity.
- 8. This unit shall only be fired on ultra-low sulfur diesel fuel, whose sulfur concentration is less than or equal to 0.0015% (15 ppm) on a weight per weight basis per CARB Diesel or equivalent requirements.
