#### **Description:**

STORAGE SILO #6, CEMENTITIOUS MATERIALS consisting of: Storage silo equipped with two WAM SiloTop Zero Passive (pulse jet) Bin Ventilation Systems, having seven Polypleat cartridge type filters with a total filter area of 264 sq ft, Air to Cloth Ratio 3.7 based on peak flow rate of 997 SCFM. Bin vent has a single compartment and has overall dimensions 73" H X 32" O.D. This unit is a 50-50 split silo that has two compartments with a combined storage capacity of 700 bbl (29,400 gallons).

#### **CONDITIONS:**

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles in a manner consistent with good air pollution control practice for minimizing emissions. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

2. This equipment shall be used for the storage and transfer of cement material only.

3. Visible emissions from this equipment shall not exceed an opacity equal to, or greater than, twenty percent (20%) for a period aggregating more than three (3) minutes in any one (1) hour, excluding uncombined water vapor [District Rule 401]. This equipment shall not discharge air contaminants or materials constituting a nuisance to any considerable number of persons or to the public [District Rule 402]. Roadways, work areas and stockpiles shall be kept sufficiently moist to control fugitive dust, and no visible emissions shall extend beyond the property line of the emission source [District Rule 403]. Equipment to properly wet the material being processed shall be maintained in operable condition on-site and used as necessary to assure compliance with this condition.

4. This equipment shall only vent to atmosphere through a properly functioning bin vent. Owner/operator shall demonstrate proper operation through periodic visible emissions evaluations.  
[District Rules 401 and 1302]

5. The owner/operator shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:

- a. Monthly visible emissions evaluations (when silo is being filled) using EPA Method 22 (and EPA method 9 if Method 22 detects visible emissions. In lieu of Method 9, o/o may cease operations until deficiencies contributing to opacity are corrected.)
- b. Records of any maintenance and repairs.

6. The o/o shall maintain on-site, as a minimum, an inventory of replacement bags that assures compliance with applicable Rules of District Regulation IV.

7. This equipment shall not be operated until baghouse under District Permit C014592 and Architectural Concrete Batch Plant under District Permit B014591 have been permanently removed from service. Facility shall notify the District once baghouse under District Permit C014592 and Architectural Concrete Batch Plant under District Permit B014591 have been removed from service. Notification can be in the form of email, sent to [engineering@mdaqmd.ca.gov](mailto:engineering@mdaqmd.ca.gov). (NOTE: Cancellation was processed on 10/1/2025)

8. This facility shall not emit equal to or greater than 15 tons of PM-10 per each consecutive 12-month period. Before this limit can be increased, the facility is required to submit to the District an application to modify the permit, which will require the use of Emission Reduction Credits or Simultaneous Emission Reductions at the facility.

9. A facility wide Comprehensive Emission Inventory Report (CEIR) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
