#### Description:

ABRASIVE BLASTING SYSTEM consisting of: 2001 U.S. Filter/Schmidt - Model 6.5CF - Serial No K-11906. The associated air compressor is a Mattei, model No. BM250 rated at 25 hp and 1,750 rpm. Facility elevation is 3036 feet above sea level.

#### CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles in a manner consistent with good air pollution control practice for minimizing emissions. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

2. All abrasive blasting operations conducted at this facility shall comply with Title 17 California Code of Regulations sections 92000-92530.

3. The owner/operator shall maintain a log which contains at a minimum the following information. The log shall be maintained current, on-site for a minimum of two years and provided to District, State or Federal personnel on request.

- type of abrasive blast material used;
- substrate of item to be blasted;
- blast nozzle diameter;
- operating pressure in psi;

- h. hours of operation in any single day (Shall not exceed 7.4 hrs/day);
- i. monthly hours of operation (shall not exceed 225 hours/month on average), and
- j. yearly total of hours of operation. (shall not exceed 7.4 hours/day X 365 days/year = 2701 hours/year.

4.This facility shall comply with District Rules 401, 402, and 403, which corresponds to Visible Emissions, Nuisance, and Fugitive Dust, respectively.  
[District Rule 1302]

- 5.Emissions from abrasive blasting operations shall not exceed the following visible emission limits for a period or periods aggregating more than three minutes in any one hour:
- a. Fully enclosed blasting- 20 percent opacity (Ringleman 1).
  - b. Open outdoor blasting- 40 percent opacity (Ringleman 2).
- [District Rule 401 and 17 CCR 92200]

Note: Visible emission observations shall be conducted in accordance with the requirements set forth in Title 17 CCR 92000-92530.

- 6.An abrasive blasting operation conducted under one or more of the following conditions is not required to be conducted within a fully enclosed area:
- a. steel or iron shot/grit is used exclusively;
  - b. the item to be blasted exceeds 8 feet in any dimension; or
  - c. the surface being blasted is situated at its permanent location or no further away from its permanent location than is necessary to allow the surface to be blasted.

7.When this abrasive blasting equipment is operated outside of a permanent building it must use exclusively abrasives certified for permissible dry outdoor blasting by the California Air Resources Board (CARB) pursuant to Title 17 CCR 92530.  
[Title 17 CCR 92500(c)(4)]

8.If the compressor used to supply air to this equipment is powered by an internal combustion engine greater than, or equal to, 50 brake-horsepower, the engine must have a valid District permit. Alternatively, the compressor power may be supplied by electrical grid.  
[District Rules 201 and 219]

9.In order to preclude triggering daily BACT threshold for PM-10 emissions, the owner/operator shall NOT OPEPARATE this equipment for more than 7.4 hours per day (day is defined as any consecutive 24-hour time period).  
[District Rule 1303(A)(2)]

10.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.  
[District Rule 107(b), H&S Code 39607 & 44341-44342, and 40 CFR 51, Subpart A]
