ABRASIVE BLASTER, ROTARY (BLDG 629) consisting of:BCP Double swing table blaster, Model CA4-5640, with integral cartridge dust collector.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2. This abrasive blasting booth shall not be operated unless vented to the functioning air pollution control device listed in the above Description.

- 3. This abrasive blasting booth must be equipped with tight fitting seals around all openings, doors, windows, seams, etc. so as to prevent the escape of particulate matter into the ambient air while in use. [District Rule 204]
- 4.The owner/operator shall not discharge into the atmosphere a visible emission with a shade as dark or darker than Ringelmann 1, or with an opacity of 20% or greater for any period aggregating more than three minutes in any one hour. [District Rules 204 and 401]
