ABRASIVE BLASTING SYSTEM, ENCLOSED consisting of:a dual station abrasive blast cabinet manufactured by Media Blast and Abrasive, Inc., Model No. Power Strip 9648, Serial No. 4016905, having inner dimensions of 96"L X 48" W X 48" H (128 cu ft), a 5 bhp motor, an integrally attached barrel separator/reclaim system and a cartridge type dust collector with four (4) filters, each measuring 12.5" diameter X 26" Long.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2. This abrasive blasting booth shall not be operated unless vented to the integral air pollution control device (dust collector) listed in the above Description.

- 3. This abrasive blasting booth must be equipped with tight fitting seals around all openings, doors, windows, seams, etc. so as to prevent the escape of particulate matter into the ambient air while in use.

- 4.The owner/operator shall not discharge into the atmosphere a visible emission with a shade as dark or darker than Ringelmann 1, or with an opacity of 20% or greater for any period aggregating more than three minutes in any one hour.

The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below for each date of use:
- a. Number of hours used;
- b. Manufacturer's name and product name/code number of each abrasive material used; and
- c. Quantity of each abrasive material used, in pounds.
