PORTABLE SCREEN PLANT consisting of: P1 Grizzly Hopper, 5' x 12' x 6' deep P2 Belt Conveyor to screen, 24" x 30' P3 Double Deck Screen, 4' x 8' P4 Belt Conveyor, fines to sand pile, 24" x 30' P5 Belt Conveyor, coarse to product pile, 24" x 30' P6 Belt Conveyor, oversize to product pile, 30" x 30' P7 Diesel Engine, Ford Industrial, 4 cyl., model 2722E, 70 hp. (drives hydraulic pump for all equipment).

CONDITIONS:

1. Materials processed shall contain sufficient natural and/or added moisture to ensure compliance with all applicable District Rules such as, but not limited to, Rules 401, 402, and 403. Sufficient water and equipment to properly wet the material being processed shall be maintained in operable condition on-site.
2. Capacity shall be limited to 100 tons/hour for sand.
3. Diesel engine shall be operated/maintained in accordance with manufacturer's specifications.
4. Daily production/operation logs shall be maintained which contain as a minimum the mass of material produced, hourly and daily, and the hours of production. The log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.
