#### **CONDITIONS:**

1. All coatings used with this equipment shall comply with applicable District Rules 1113 (Architectural Coatings), 1114 (Wood Products Coatings), 1115 (Metal Products Coatings), 1116 (Automotive Refinishing Operations) or 442 (Usage of Solvents).

2. A daily record shall be maintained of the VOC emissions from this facility which contains but is not limited to the following:

- a. Equipment used to apply coating
- b. Type of coating used, applicable District rule and VOC limit
- c. Quantity of coating used and VOC content
- d. Total VOC emissions if coating covered by Rule 1113, 1114, 1115, or 1116
- e. If coating is covered by Rule 442:
  - (1) Total VOC emissions NOT photochemically reactive
  - (2) Total VOC emissions photochemically reactive
- f. Total VOC emissions

This information shall be maintained on-site for a minimum of two (2) years and be provided to District personnel on request.
