Description:

SOIL REMEDIATION consisting of:Equipment which includes a water pump for extraction of water from below ground, a tank to hold this water which is contaminated with chlorinated organics. Inside the tank is an air sparger for aeration of the water pumped therein. A blower for the tank/sparger is also provided as are the necessary instrumentation, valving, piping, electrical and other necessary equipment.

CONDITIONS:

- 1. Operation of this equipment shall be in strict compliance with all information submitted with the application for this permit, unless specifically exempted hereunder.
- 2. During these operations, determinations for VOCs shall be made using an electron capture detector (ECD), or another method which this District finds equivalent.
- 3.Emissions determinations shall be made during the first two days of initial start-up. Subsequent to the initial readings, the monitoring may be reduced to monthly bag samples with analyses according to EPA Methods, until completion of the project.
- 4. Emissions samplings shall be measured at the exhaust of the sparge tank.
- 5.On-site measurement methods shall be considered invalid unless calibrations are performed with a known concentration of a chlorinated VOC which is present in the emissions.
