- 2. Water processed through this sludge treatment system shall be treated at the Tertiary Treatment Plant, Permitted by valid District Permit B010540, prior to its use as recycled irrigation water.
- 3. This facility shall not treat more than 2 millions gallons of waste water per day.
- 4.The owner/operator, o/o, shall log the daily volume of wastewater received and treated. The log shall be maintained current, on-site for a minimum of 2 years and provided to District personnel on request.
