Description:

HYDRAULIC PRESS #4 -WILLIAMS WHITE consisting of: 1000 ton capacity unit, model No. C-4042-A or equivalent and to be determined by availability of the market place. These new presses (B004876 through B004891) are served by the following equipment which are proposed to be identical to the equipment described on District permit B004646. A. Littford Ploughshare Mixer, model FKM-600-D, serial No. 3421, which is described as a 60 hp driven assembly on 230/460 volts; B. BMC Extruder, model H-900 with a 9" diameter screw, 7 1/2' L; and C. BMC Mixing tank assembly, whose capacity is 250 gallons with a single rod-2 stinger shaft mixer, driven by a 5 hp motor.

CONDITIONS:

1. The owner/operator (o/o) shall install, operate, and maintain this equipment in strict accord with those recommendations of the manufacturer and with those principles consistent with minimum emissions.
2. The o/o shall log the total mass of material fed to this press on a daily basis. This log shall be maintained current, on-site, and provided to District personnel on request.
3. Resin used to make the material to be used in this press shall not exceed 35% on a weight per weight basis of styrene. Each shipment of styrene containing resin shall be accompanied by a supplier data sheet. The data sheet shall show the resin content of styrene. These data sheets shall accompany the log required in 2. above.
4. Emissions of VOCs at this facility from all non-mobile sources shall not exceed 240 lb/day, when computed on a 30 day rolling average. Additionally, VOC emissions from both the mixing of press materials and their processing in the presses shall not exceed 24.5
