1. Bucket elevator 321BE102 and belt conveyor 321BC104 shall not be operated unless vented to baghouse C007441 (321BF102). Air slides 321AS101, 321AS102, and 321AS103 shall not operate unless vented to baghouse C007451 (321BF103). Air slide 321AS104 shall not be operated unless vented to baghouse C007444 (321BF104). [District Rules 204; 1303(A)]

3. All equipment shall be operated in compliance with applicable requirements 40 CFR 63 Subpart LLL - National Emission Standard for Hazardous Air Pollutants from the Portland Cement Manufacturing Industry. [40 CFR Part 63 Subpart LLL]
