#### **Description:**

COMPOST AND GREEN WASTE BLENDING AND SCREENING EQUIPMENT consisting of: Grizzly Hopper, Retech Feed Hopper, Retech Trommel Screen, connected by conveyors. Final discharge to two storage piles; a prepared green waste pile, and finished composed pile. Power provided by CARB registered 125 bhp diesel fueled genset.

#### **CONDITIONS:**

1. The owner/operator (o/o) shall operate this equipment in strict accordance with the manufacturer's specifications and/or sound engineering principles.
2. Operation of the equipment described above shall be conducted as described in the data and specifications submitted with the application under which this permit is issued.
3. Roadways, work areas, stock piles, and materials being processed shall be kept wetted to control fugitive dust. Equipment to properly wet the material being processed shall be maintained in operable condition on-site and used as necessary to assure compliance.
4. The owner/operator shall comply with all applicable Rules and Regulations of the District. Applicable rules include, but are not necessarily limited to Rules 401, 402, and 403.
5. The CARB registered 125 bhp diesel fueled genset shall be used for equipment electrical power not to exceed one year from the date of issuance of this permit. Thereafter, a District Permitted genset or line power must be utilized.
