SILICA MANUFACTURING ELUTRIATION AREA consisting of:Up to thirty-two 55 gallon settling drums (area vented to atmosphere through a stack), and a chemical hood (vented to atmosphere through a stack). Note that this area includes an exempt 6.8 cubic foot 1.36 kWh reactor (30" W by 28" L by 20" H) which only processes silica and water.

CONDITIONS:

1. This equipment shall be operated in accordance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.

3. This facility shall emit less than the following on an annual (any twelve consecutive month period) basis to remain under the USEPA's Synthetic Minor, 80% (SM-80) limits, calculated as the total emissions from all permitted equipment:

Oxides of Nitrogen (NOx) - 20 tons,

Volatile Organic Compound (VOC) - 20 tons,

Particulate Matter less than 10 microns (PM10) - 12.5 tons, and

Hazardous Air Pollutants (HAPs) - 8 tons per year for any single HAP and 20 tons per year for any combination of HAPs.

Compliance shall be demonstrated to the District through the submission of a District approved Comprehensive Emission Inventory (CEI) report or other District approved equivalent method.

- 4. The owner/operator (o/o) shall maintain a current, on-site operations log for this facility for a minimum of two (2) years, and shall provide the operations log to District personnel on request. The operations log shall, at a minimum, contain the information specified below.
- a. Cumulative monthly VOC emissions (in pounds);
- b. Cumulative annual (twelve month summary) VOC emissions (in pounds or tons);
- c. Monthly HAP emissions (in pounds); and,
- d. Cumulative annual (twelve month summary) HAP emissions (in pounds or tons).

5.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
