One Yanmar, Diesel fired internal combustion engine Model No. 4TNV98T-GGEH and Serial No. 42550, Direct Injected, Electronic Control Module, Turbo Charged, producing 68 bhp with 4 cylinders at 1800 rpm while consuming a maximum of 3.4 gal/hr. This equipment powers a Himoinsa/Stamford Generator Model No. A07E789281 and Serial No. 0227558/041, rated at 42.5 kVA.

2. This engine shall not be operated for more than 2,600 hours in any consecutive 12 month period.  
[MDAQMD Rule 1302]

3. This engine shall only be fired on diesel fuel that meets the following requirements, or an alternative fuel approved by the District:

a. Ultra-low sulfur concentration of 0.0015% (15 ppm) or less, on a weight per weight basis; and,  
b. A cetane index or aromatic content, as follows:

1. A minimum cetane index of 40; or,
2. A maximum aromatic content of 35 volume percent.

[17 CCR 93116, MDAQMD Rule 431]

Note: Use of CARB certified ULSD fuel satisfies the above requirements.

4. This diesel ICE and its associated equipment cannot be operated at the same engine-print (spot) for more than 365 consecutive days.  
(This system must be moved for a valid operational reason within this facility or moved to another facility annually.)

5. This engine shall not be located within 1,000 feet of any residence or K-12 school.

[MDAQMD Rules 204 and 1320]

6. The owner/operator shall maintain an operations log for this engine current and on-site (or at a central location) for a minimum of three (3) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the following information:

- a. Monthly Hour Meter Readings;
- b. Date of each maintenance action or repair;
- c. Description of each maintenance action or repair;
- d. Fuel sulfur concentration as required by condition #3 (the o/o may use the supplier's certification of sulfur content if it is maintained as part of this log); and,
- e. Results of any source testing conducted on the engine.

7. This engine shall not be operated within the state of California on or after January 1st, 2022.

[Title 17 CCR 93116.3(c)(1)]

8. This unit is subject to the requirements of the Airborne Toxic Control Measure (ATCM) for Portable Compression Ignition Engines (Title 17 CCR 93116). In the event of conflict between these conditions and the ATCM, the more stringent requirements shall govern.

9. TA facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
