OnePSI (GM),LPG fired internal combustion engine Model No.Vortec 5.7L and Serial No.39002086,Three-Way Catalyst (also NSCR), producing105 bhp with8 cylinders at1800 rpm while consuming a maximum of9.7gal/hr. This equipment powers aKohlerGenerator Model No.60REZGB and Serial No.SGM32BHK8, rated at52 KW.

Brad Poiriez Air Pollution Control Officer 2.This unit shall be fired on Liquified Petroleum Gas (LPG) fuel with a Sulfur content of less than 185 ppmw.Note: Use of Commercial Grade Liquified Petroleum Gas satisfies this requirement.[40 CFR 60.4243, District Rule 431]

3.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [40 CFR 60.4237]

4. The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:

a. Monthly fuel usage in cubic feet or gallons;

b. Monthly and calendar year operation in terms of total hours; and

c. Records of all maintenance and repair actions performed on the engine, the AFRC, and the catalytic converter.

5. The Air-to-Fuel Ratio Controller shall be used in conjunction with the control device, and shall be maintained and operated appropriately to ensure proper operation of the engine and control device to minimize emissions at all times. [40 CFR 60.4243]

6.The catalytic converter shall be cleaned in accordance with the manufacturer's written procedures when the pressure differential across the converter exceeds two (2) inches water column above its initial reading at startup.
[40 CFR 60.4243, District Rule 1302]

7.In the event that the Three-Way Catalytic Converter is replaced, the new (replacement) Catalytic Converter must be of the same Manufacturer and model designation and it must be installed by Factory Certified personnel to avoid follow-on source testing.

If the Manufacturer or the Model designation of the new (replacement) catalytic converter is not identical to the original catalytic converter or if the unit is not installed by Factory Certified personnel, then the engine shall be source tested in accordance with the procedures outlined in 40 CFR 60.4244 within 90 days after the catalytic converter replacement. The source test results must verify that the engine meets the following maximum emission limits (measured at standard conditions): a. NOx + NMHC: 2.0 g/bhp-hr b. CO: 3.28 g/bhp-hr [40 CFR 60.4243, 40 CFR 60.4244, District Rules 1302]

8. This engine is subject to the requirements of the New Source Performance Standards (NSPS) for Stationary Spark Ignition IC Engines (40 CFR 60, Subpart JJJJ). [District Rule 1302]

9.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request. [District Rule 107(b), H&S Code 39607 & 44341-44342, and 40 CFR 51, Subpart A]
