One Cummins, Diesel fired internal combustion engine Model No. QSL9-G8 and Serial No. 73404999, After Cooled, Compression-Ignited, Diesel Particulate Filter, Electronic Control Module, Exhaust Gas Recirculation, Exhaust Gas Recirculation, Turbo Charged, producing 433 bhp with 6 cylinders at 1800 rpm while consuming a maximum of 21.6 gal/hr. This equipment powers a Multi-Quip Generator Model No. DF-3300C and Serial No. 740227, rated at 323 kW.

contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

[District Rule 1302]

2.This diesel ICE and its associated equipment cannot be operated at the same engine-print (spot) for more than 365 consecutive days, excluding time spent at a designated storage site. (This generator must be moved to another facility annually for a valid operational reason.)

[Title 17 CCR 93116.2(a)(29)]

3.This unit shall only be fired on ultra-low sulfur diesel fuel whose sulfur concentration is less than or equal to 0.0015% (15 ppm) on a weight per weight basis per CARB Diesel or equivalent requirements; or alternative diesel fuel, or CARB diesel fuel utilizing fuel additives, that has been verified through the Verification Procedure for In-Use Strategies to Control Emissions from Diesel Engines.

4.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time.

[District Rule 1302(C)(2)(a) and Title 17 CCR 93116]

5.The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:

- a. Date of each use, location of each use (decimal degrees, xx.xxxxx;-yyy.yyyyy) and duration of each use (in hours);
- b. Reason for use (regular use, testing & maintenance, emergency use, required emission testing);
- c. Calendar year operation in terms of fuel consumption (in gallons) or total hours (to assist in CEI data collection);
- d. Description of all repairs and/or maintenance actions on emission control systems; and,
- e. Fuel sulfur concentration (the o/o may use the supplier's certification of sulfur content if it is maintained as part of this log).

6.This unit shall not operate within 1000 feet of the outer boundary of any K-12 school for more than 45 days. Such operation will require the submittal of an application for a revised permit to operate so that the applicable requirements of the California Health and Safety Code Section 42301.6 will be met.

7.The fleet of portable diesel engines under control of this owner/operator are subject to the requirements of the Airborne Toxic Control Measure For Diesel Particulate Matter From Portable Engines Rated At 50 Horsepower and Greater (Title 17 CCR 93116). In the event of conflict between these conditions and the ATCM, the more stringent shall govern.

8.In each calendar year, the actual emissions of this facility shall be less than 20 tons NOx, 20 tons VOC, and 12 tons PM10 (SM80 Emission Rate). The owner/operator shall demonstrate compliance with this limit on an annual basis through the submission of the Comprehensive Emission Inventory Report (CEIR) to the District. Copies of the CEIR(s) must be kept and maintained on-site for at least five years and presented to District personnel upon request.
