- 3.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed boiler operating time. [District Rule 1303(B)]
- 4. The owner/operator shall maintain an operations log for this equipment on-site and current for a minimum of two (2) years, and shall be provided to District personnel on request. The operations log shall include the following information at a minimum:
- a. Total operating time in hours per month and total hours per running consecutive 12 month period; and,
- b. Total fuel consumed, in gallons or Standard Cubic Feet, per month and per running consecutive 12 month period. [District Rule 1302(C)]
- 5. This facility must submit accurate emissions inventory data to the District, in a format approved by the District, upon District request. [District Rule 204]
