#### **Description:**

SPIN TEST CELL, TACTICAL VEHICLE ENGINE TESTING (UNIT 1) consisting of: A custom manufactured engine test stand designed to allow tactical vehicle engine operations in an unloaded state. Facility Elevation is 1964 ft above MSL.

1. The owner/operator shall maintain an operations log for this equipment, current and on-site, either at the equipment location or at an on-site location, for a minimum of five (5) years and this log shall be provided to District, State or Federal personnel on request. The log shall include, at a minimum, the following information for each test run:

- a. Date and run duration of each engine's operation,
- b. Fuel consumed, in gallons, by the operating engine, and
- c. Maximum developed brake hp of the engine being tested (n/a for spin tests only).

5. A facility-wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
