Description:

PLANT OIL EXTRACTION SYSTEM AND PURIFICATION PROCESSES, CANNABIS consisting of:Ethanol extraction process utilizing one 500 liter extraction vessel manufactured by Northland Stainless. Inc., a centrifuge and one BZB Silver Serpent falling film evaporator manufactured by Bizybee. Post processing and purification processes use ethanol. Ethanol extraction is not closed loop but does occur at -35 degrees C or lower.

CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2. The only volatile organic compound (VOC) solvents that can be used in the Oil Extraction process (includes refinement and distillation) process is ethanol. Prior to changing solvent, the owner/operator must apply for a permit modification and have the approved, modified permit before making the change.

- 3.The only non-exempt VOC solvents that can be used in post processing is ethanol. Prior to changing solvent, the owner/operator must apply for a permit modification and have the approved, modified permit before use.

- 4.An operations log for this equipment must be kept for a period of two (2) years, must be kept on site, and must be made available upon request of District personnel. This log shall contain, as a minimum, the following information:

- a. The date and hours of operation each time the Oil Extraction process is operated;
- b. Monthly, and calendar year totals of the gallons of all ethanol used in the oil extraction and post processing; and,
- c. Copies of the Environmental Data Sheet and/or Material Safety Data Sheet (MSDS) for each solvent and material used in the Oil Extraction process.

- 5.The owner/operator must take all steps necessary to preclude odor migration from this facility, including but not limited to:
- a. If using any internally-exhausting activated carbon canister odor control devices, conduct carbon filter change outs whenever breakthrough is indicated (externally vented odor control devices require a separate District Permit);
- b. Keeping doors and windows closed to the maximum extent possible; and
- c. Isolating odor-emitting activities from other areas of the buildings through closing doors and windows. [District Rule 402]
- 6.All solvent storage containers shall be maintained in a leak-free condition at all times when not in use. [District Rule 442]
- 7.All VOC containing materials, whether in its form for intended use or as a waste or used product, shall be stored in nonabsorbent, non-leaking containers which shall be kept closed at all times, except when filling or emptying, and disposed of in a manner to prevent evaporation of VOCs into the atmosphere at the Facility.

- 8. This facility shall not emit greater than 1190 pounds per month VOCs (180 gallons ethanol lost to atmosphere). This limit is observed provided the facility maintains compliance with condition #4. [District Rule 442]
- 9.Exhaust from this equipment shall not be vented to the atmosphere through any type of air pollution control device (APCD) without first obtaining an additional APCD permit from the District.

- 10.No internal combustion engines with a maximum rated power of 50 bhp or greater may be used at this facility withoutfirst obtaining an additional operating permit from the District.

- 11.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
