2. This engine shall not be operated unless all of the following engine systems are properly functioning:

- a. Engine Control Module
- b. Turbocharger
- c. Charge Air Cooler
- d. Electronic Direct Injection
- e. Exhaust Gas Recirculation
- f. Diesel Oxidation Catalyst
- g. Selective Catalyst Reduction-Urea
- h. Ammonia Oxidation Catalyst

Furthermore, no changes shall be made to any of the above systems unless done so by a factory certified technician. [District Rule 1302]

3. This equipment shall only be fired on diesel fuel that meets the following requirements, or an alternative fuel approved by the ATCM for Stationary CI Engines:

a. Ultra-low sulfur concentration of 0.0015% (15 ppm) or less, on a weight per weight basis; and,

- b. A cetane index or aromatic content, as follows:
- 1. A minimum cetane index of 40; or,
- 2. A maximum aromatic content of 35 volume percent.
- [17 CCR 93115.5(a), 40 CFR 80.510, and 40 CFR 60.4207(b)]

Note: Use of CARB certified ULSD fuel satisfies the above requirements.

4.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [17 CCR 93115.10(d)(1) and 40 CFR 60.4209(a)]

5. This Engine shall not consume more than 76,911 gallons of Diesel fuel per year (based on full load 19.23 gal/hr X 4000 hrs/yr). [District Rule 1320]

6. The owner/operator shall maintain an operations log for this unit, current and on-site (or at a central location), for a minimum of three (3) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:

- a. Daily hour meter reading when engine is started and daily hour meter when engine is shut down;
- b. Calendar year operation in terms of total hours;
- c. Fuel used by Engine, including weekly, monthly and calendar year totals (shall not exceed 62,284 gals/yr).
- d. Fuel sulfur concentration (may use the fuel supplier's certification of sulfur content if it is maintained as part of this log).
- [17 CCR 93115, District Rules 1302 and 1320]

7. This engine is subject to the requirements of Title 17 CCR 93115, the Airborne Toxic Control Measure (ATCM) for Stationary Compression Ignition Engines and 40 CFR 60, Subpart IIII - Standards of Performance for Stationary Compression Ignition Internal Combustion Engines (NSPS). In the event of a conflict between these conditions and the ATCM or NSPS, the more stringent requirements shall govern. [District Rule 1302]

8.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
