CUSTOM FLASH OVEN #3 consisting of:an electric paint dryng oven manufactured by Davenport, Model 4X4X6, Serial No. HS-186, dimensions 4' W X 6' H X 4' L (total 96 cubic feet) with an operating temperature of 250 degrees Fahrenheit, and exhaust of 400 cfm, with 6" diameter outlet. Stack Height 19' from ground level. Elevation: 2,616'

CONDITIONS:
