### **Description:**

PLANT OIL EXTRACTION AND DISTILLATION SYSTEM (ETHANOL), CANNABIS consisting of:Two Delta Cup-30 ethanol extraction systems, Five Delta Cup-15 ethanol extraction systems, Two Bizzy Bee falling film evaporators, one Delta Separations falling film evaporator, a DCI Inc 150L jacketed pressure vessel (for decarb), a Pilot-15 Myers Wiped Film Distillation system, and a Lab 1st Dual staged Wiped Film system. Work-in-progress room contains four 5-barrel and one 10 barrel ethanol solvent storage barrels. The falling film, wiped film, and decarb processes take place in an explosion proof room classified as Class 1, Division 1, spark free, with large and rapid air exchange rates; C1D1 rooms are typically used to contain the extraction equipment and have an emergency air intake and exhaust system that can operate at very high air exchange rates, such as 14,000 CFM. These rooms typically employ a continuous airflow system that can operate at 10,000 CFM.

#### **CONDITIONS:**

- 1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]
- 2. The only solvent that can be used in the Oil Extraction process is ethanol. Prior to changing solvent, the owner/operator must apply for a permit modification and have the approved, modified permit before use.

  [District Regulation XIII]
- 3.A log pertaining to the operation of this equipment must be kept for a period of two (2) years. The last two years' records must be kept on site, and must be made available upon request of District personnel. This log shall contain the following information:
- a. The date and hours of operation each time the Oil Extraction process is ran; and,
- b. Daily, monthly, and calendar year totals of the gallons of solvent used and pounds of VOCs emitted, in the Oil Extraction process;

c. Copies of the Environmental Data Sheet and/or Material Safety Data Sheet (MSDS) for each solvent and material used in the Oil Extraction process.

[District Rule 1302]

4. The owner/operator must take all steps necessary to preclude odor migration from this facility, including but not limited to, carbon filter change outs whenever breakthrough is indicated, keeping doors and windows closed to the maximum extent possible, isolating odor-emitting activities from other areas of the buildings through closing doors and windows, and operating air filters continuously during cultivation activities.

[District Rule 402]

5. This equipment shall not emit more than 25 lbs VOCs per day. Further, this facility shall not emit more than 1190 lbs VOCs per month.

[District Rule 442 and Regulation XIII]

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
