STRIP OVEN - INCINERATOR consisting of: Ramco natural gas fired oven is rated at 1.6 MMBtu/hr and operates between 650 - 800 degrees F. The built-in afterburner operates at 1,450 degrees F. Oven enclosure dimensions are 6'W X 6'L X 6'H. Equipment previously permitted as B004037 at 17437 Lemon Street Hesperia, CA 92345. Facility elevation is 3080 feet above sea level.
