Description:

STEAM BOILER - LPG/PROPANE consisting of: A 2.0 MMBtu/hour LPG/propane fired Kemco Systems steam generator, Model # 2MIL, serial number VE27725, operating at a maximum temperature of 210 degrees Fahrenheit. Maximum hourly fuel usage is 21.9 gallons per hour.

CONDITIONS:

1. This equipment shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or in a manner consistent with safety and good air pollution control practices for minimizing emissions. Furthermore, operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued.

2. This equipment is limited to using only liquid propane gas (LPG).

3. A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed unit operating time.

4. The owner/operator shall maintain an operations log for this equipment on-site and current for a minimum of two (2) years, and said log shall be provided to District personnel on request. The operations log shall include the following information at a minimum:
