- 1. This stationary, spark-ignited, internal combustion engine and its associated control device (Three-Way Catalyst) and air/fuel ratio controller shall be installed, operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

 [40 CFR 60, Subpart JJJJ Standards of Performance for Stationary Spark Ignition Internal Combustion Engines, subpart 60.4243; District Rule 1302]
- 2.This unit shall be fired on Liquified Petroleum Gas (LPG) fuel with a Sulfur content of less than 185 ppmw. Note: Use of Commercial Grade Liquified Petroleum Gas satisfies this requirement. [40 CFR 60.4243, District Rule 431 and]
- 3.A non-resettable four-digit (9,999) hour timer shall be installed and maintained on this unit to indicate elapsed engine operating time. [40 CFR 60.4237]
- 4. The owner/operator shall maintain an operations log for this unit current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and Federal personnel upon request. The log shall include, at a minimum, the information specified below:
- a. Monthly fuel usage in cubic feet or gallons;
- b. Monthly and calendar year operation in terms of total hours; and
- c. Records of all maintenance and repair actions performed on the engine, the AFRC, and the catalytic converter. [40 CFR 60.4245, 40 CFR 1048, District Rule 1110.2]
- 5.The Air-to-Fuel Ratio Controller shall be used in conjunction with the control device, and shall be maintained and operated appropriately to ensure proper operation of the engine and control device to minimize emissions at all times. [40 CFR 60.4243]
- 6. The catalytic converter shall be cleaned in accordance with the manufacturer's written procedures when the pressure differential across the converter exceeds two (2) inches water column above its initial reading at startup.

 [40 CFR 60.4243, District Rule 1302]

7.In the event that the Three-Way Catalytic Converter is replaced, the new (replacement) Catalytic Converter must be of the same Manufacturer and model designation and it must be installed by Factory Certified personnel to avoid follow-on source testing.

If the Manufacturer or the Model designation of the new (replacement) catalytic converter is not identical to the original catalytic converter or if the unit is not installed by Factory Certified personnel, then the engine shall be source tested in accordance with the procedures outlined in 40 CFR 60.4244 and District Rule 1160 within 90 days after the catalytic converter replacement. The source test results must verify that the engine meets the following maximum emission limits (measured at standard conditions):

- a. NOx: 50 ppmv (per district rule 1160);
- b. CO: 2.0 g/hp-hr (per Emission standards Subpart JJJJ), and
- c. VOC: 0.2 g/hp-hr (per Emission standards Subpart JJJJ).

[40 CFR 60.4243, 40 CFR 60.4244, District Rules 1160, 1303 and 1320]

- 8. This engine must be inspected at least once each quarter or after every 2,000 hours of operation, whichever is more frequent. An inspection includes any testing, maintenance, and/or other procedures that ensure the engine is operated in strict accordance with the manufacturer's specifications and in continual compliance with the provisions of District Rule 1160. Records of such inspections must include the following information as a minimum:
- a. Inspection Date:
- b. Records of testing, as applicable; and
- c. Records of maintenance.

9. The owner/operator must comply with the following emission standards, as referenced below, over the entire life of the engine. Compliance must be determined in accordance with the performance test methods and procedures specified in 40 CFR 60.4244 and Table 1 to Subpart JJJJ.

Maximum Allowed Emission Standards:

- a. NOx: 50 ppmv (per district rule 1160);
- b. CO: 2.0 g/hp-hr (per Emission standards Subpart JJJJ), and
- c. VOC: 0.2 g/hp-hr (per Emission standards Subpart JJJJ).
