2.This equipment shall not be operated unless the Clearvue CV1950 Dust Collector is properly operating in conjunction with this system.

\*Note - dust collector exhausts inside the building.

3.This manufacturing line shall not produce more than 108 tons per year of finished product, calculated on a rolling twelve month basis.

[District Rule 1303 - NSR Requirements]

4.All fragrance added to the manufacturing line shall be limited to no more than 2,160 lbs/year and no more than 1,190 lbs in any one month period.

[District Rules 442 and 1303]

5.The owner/operator of this facility shall maintain current and on-site for two (2) years a log of the following information, which shall be provided to District upon request:

a. Material Safety Data Sheets (MSDS), or other data provided by the manufacturer, for each fragrance used;

b. lbs/month of each fragrance used;

c. Monthly finished production, in pounds or tons;

d. Cumulative, last twelve-month finished production, in pounds or tons for the manufacturing line;

e. Cumulative, last twelve-months total fragrance used in lbs/year;

f. Quarterly Visible Emission Determinations, date and result, using the following procedures: Ensure that the observation spot provides a clear view of the emission point, observe the emission point for a period of one minute, and designate the emission point as "dusting" or "not dusting". If "dusting" is occurring, shut down the equipment immediately until repairs are made;

g. Quarterly inspection date and results;

h. Date of filter replacements; and,

i. Date and nature of any system repairs.

6.Visible emissions from this equipment shall not exceed an opacity equal to, or greater than, twenty percent (20%) for a period aggregating more than three (3) minutes in any one (1) hour, excluding uncombined water vapor [District Rule 401]. This equipment shall not discharge air contaminants or materials constituting a nuisance to any considerable number of persons or to the public [District Rule 402]. All work areas shall be kept sufficiently clean to control fugitive dust, and no visible emissions shall extend beyond the property line of the emission source [District Rule 403].

7.The owner/operator shall maintain, on-site, a minimum inventory of replacement filters for this equipment that assures compliance with these conditions.

[District Rule 401 - Visible Emissions, District Rule 403 - Fugitive Dust and District 402 - Nuisance]

8.This facility shall maintain, and have available upon District request, a Fragrance Management Plan consisting of a written description of operating procedures and practices mandated to control fragrance/odors and preclude nuisance.

[District 402 - Nuisance]

9.At the District's request, this facility must install air pollution control devices, specific to the control of odor, on all equipment venting to the atmosphere and any source of odor release.

[District 402 - Nuisance]

10.All VOC containing materials, whether in its form for intended use or as a waste or used product, shall be stored in nonabsorbent, non-leaking containers which shall be kept closed at all times, except when filling or emptying, and disposed of in a manner to prevent evaporation of VOCs into the atmosphere at the Facility.

11.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
