DUST CONTROL SYSTEM (BSS02) consisting of:a chemical dust suppression system, Model CR5-10 with a three phase 3 hp pump. This system serves the secondary crusher system (B000081) and the transport belts to CBC9 and CBC10 (B001666).

CONDITIONS:

1. The owner/operator (o/o) shall operate all equipment described in this permit in strict accord with the recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emission of air contaminants. [District Rule 204]

2. The o/o shall maintain a log of all inspections, repairs, and maintenance on this equipment and submit it to the District on request. The log shall be kept for a minimum period of five years. [District Rule 204]

3. This equipment shall operate concurrently with the secondary crushing system (B000081) and transport belts to CBC9 and CBC10 (B001666), as applicable. [District Rule 204]

4.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
