#### **Description:**

BAGHOUSE BH22302 (MERRICK SCALE) consisting of: a Griffin Environmental Model No. 50-S77 pulse air-cleaned baghouse, with 72 4.5" D by 52" L treated polyester bags totaling 368 square feet of filter area and a 10 hp fan generating 2190 scfm of flow (for an air to cloth ratio of 6:1). This device serves the Merrick Belt Scale (B000849).

#### **CONDITIONS:**

1. This equipment shall be operated concurrently with the Merrick Belt Scale covered in District permit B000849.
2. The owner/operator (o/o) shall maintain this equipment in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.
3. The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and on-site for five (5) years a log of the following information, which shall be provided to District personnel upon request:
  - a. Monthly baghouse stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
  - b. Quarterly bag and bag suspension system inspection date and results;
  - c. Date of bag replacements; and,
  - d. Date and nature of any system repairs.

4. This baghouse shall discharge no more than 0.19 pounds per hour of PM10 at a maximum concentration of 0.01 grains/dscf at the operating conditions given in the above description. This equipment does not require a regularly scheduled emission compliance test.

5. The o/o shall maintain on-site a minimum inventory of replacement bags for this equipment that assures compliance with these conditions.
