### **CONDITIONS:**

- 1. The owner/operator (o/o) shall install, operate and maintain this dust collector in strict accord with those recommendations of the manufacturer/supplier, and sound engineering principles which produce minimum emissions of air contaminants.
- 2.The o/o shall conduct a minimum program of inspection and maintenance on this equipment. The o/o shall maintain current and onsite for five (5) years a log of the following information, which shall be provided to District, State or Federal personnel upon request:
- a. Weekly baghouse stack observation date and result (using USEPA Method 22, and USEPA Method 9 if necessary);
- b. Quarterly bag and bag suspension system inspection date and results;
- c. Date of bag replacements; and,
- d. Date and nature of any system repairs [Rule 204]
- 3. The o/o shall log all the items in 2 above in addition to the bag replacements, repairs and non-scheduled maintenance. The log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.
- 4.The o/o shall maintain an inventory of replacement bags on-site at all times which will ensure compliance with applicable Rules of District Regulation IV.
