## **CONDITIONS:**

- 1. The owner/operator (o/o) shall operate/maintain this equipment in strict accord with recommendations of the manufacturer and/or sound engineering practices.
- 2. The operating instructions shall be immediately available for use by the operator and provided to District personnel upon request.
- 3. This equipment shall be operated concurrently with cement silos 1, 2, 3, 4, and 5 covered in District permit B000059.
- 4. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specifications which ensures compliance with District Rules. This program shall include, but not be limited to, regular opacity readings, pressure differential measurements, and maintenance inspections. Logging of these data shall be required with the log kept on-site for a minimum of two years. This log shall be provided to District personel on request.
- 5. Within 60 days of initial start-up, the o/o shall conduct a compliance test in accordance with the District Compliance Test Procedural Manual. This test is required to show compliance with permit conditions and Rules 404 and 405. The District shall be notified at least 10 working days prior to the test date. The test report shall be submitted to the District within 45 days following the tests.
