## **Description:**

WET/DRY ASBESTOS VACUUM CLEANER consisting of:a Pullman-Holt Wet/Dry Asbestos Vacuum Cleaner. This unit is model 102ASB-12P, serial number R-060372 with a capacity of 12 gallons, liquid. This unit is used to clean repairs on asbestos and semi-metallic brake shoes and new installations. It is equipped with a HEPA filtering system as back-up to [polyester filters 1 in thick.

### **CONDITIONS:**

- 1. The HEPA filters shall meet UL 585 and UL 900 class 2 requirements.
- 2. This air filtration unit shall be operated and maintained in strict accord with those recommendations of the manufacturer.
- 3. This facility shall emit less than the following on a calendar year basis;

Oxides of Nitrogen (NOx) - 25 tons,

Volatile Organic Compound (VOC) - 25 tons,

Particulate Matter less than 10 microns (PM10) - 15 tons, and

Hazardous Air Pollutants (HAP) - 10 tons per year for any single HAP and 25 tons per year for any combination of HAPs. Compliance shall be demonstrated annually to the District through the submission of a District approved Comprehensive Emission Inventory Report (CEIR) or other District approved equivalent method. The report shall be submitted to the District no later than April 30 of each year.
