#### **Description:**

BAGHOUSE (45-011) consisting of: A Flex-Kleen baghouse, whose air to cloth ratio is 3:1. This baghouse is designed to work at ambient conditions and has 670 square feet of filtering area. The unit is served by a 2000 ACFM fan driven by a 7.5 hp electric motor. This unit serves the Roller Mill Number 4 feed silo (45-010).

#### **CONDITIONS:**

1. The owner/operator, (o/o), shall operate/maintain this equipment in strict accord with recommendations of the manufacturer and/or sound engineering practices.

2. The operating instructions shall be immediately available for use by the operator and provided to District personnel upon request.

3. This baghouse shall operate concurrently with the Tertiary Crushing System under valid District permit B000757.

4. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specification which ensures compliance with District Rules. This program shall include, but not be limited to, regular opacity readings, pressure differential measurements, and maintenance inspections. Logging of data shall be required with the log kept on site for a minimum of two (2) years. This log shall be provided to District personnel on request.

5. This baghouse does not require regular emissions testing, but the District may require testing at its discretion.  
[District Rule 204]

6. The facility-wide emissions must be less than the following limitations in each consecutive twelve-month period:

- a. 80 tons per year of Carbon Monoxide (CO) per calendar year;
- b. 20 tons per year of Oxides of Nitrogen (NO<sub>x</sub>) per calendar year;
- c. 20 tons per year of Volatile Organic Compounds (VOC) per each consecutive twelve-month period;
- d. 80 tons per year of Particulate Matter of 10 microns or less (PM<sub>10</sub>) per calendar year;
- e. 20 tons per year of Oxides of Sulfur (SO<sub>x</sub>) per calendar year;
- f. 8 tons per year of any single Hazardous Air Pollutant (HAP) per calendar year; and,
- g. 20 tons per year of any combination of HAP per calendar year.

Compliance with these emission limitations must be verified by pollutant-specific emission summaries for each calendar year except for PM-10 which must be verified for each consecutive twelve-month period. These emission summaries must be retained on-site for a minimum period of five (5) years; and, must be made available for review upon request by District, State or Federal personnel.

In addition, this facility is designated as a Major Source of PM<sub>10</sub> under Regulation XIII - New Source Review, as it has a Potential to Emit in an amount equal to or greater than 15 tons per year of PM<sub>10</sub>; therefore, any new Permit Unit or any Modified Permit Unit at this facility must be fully offset pursuant to District Rule 1303(B).

7. This facility must submit a Comprehensive Emissions Inventory Report (CEIR) to the District in accordance with District CEI Guidelines and in a format approved by the District, on an annual basis.
