Description:

BAGHOUSE - PRIMARY AND SECONDARY RECLAIM CONVEYORS consisting of: FFNW, model 81-10, which has 1000 sq ft of filter surface area which is served by a 30 hp New York Blower, model 224.

CONDITIONS:

1. The owner/operator, (o/o), shall operate/maintain this equipment in strict accord with recommendations of the manufacturer and/or sound engineering practices.
2. The operating instructions shall be immediately available for use by the operator and provided to District personnel upon request.
3. This baghouse shall be operated concurrently with the Rock Reclaim System Conveyors: 40-606, 40-506, 40-406, 40-306, 40-206, 40-106 pick-up points and that pick-up point where conveyor 40-107 (near the metal detector) drops to conveyor 40-108 under valid District permit B000755.
4. The o/o shall have a continuing program of maintenance/inspections in accord with manufacturer's recommendations and specifications which ensures compliance with District Rules. This program shall include, but not be limited to, regular opacity readings, pressure differential measurements, and maintenance inspections. The o/o shall log these data. The log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.
5. This equipment does not require a regularly scheduled emissions compliance test. However, emissions compliance testing may be required at the discretion of the District.
